DESCRIPTION

FIG. 1 is a front perspective view of an audio speaker in accordance with my new design;

FIG. 2 is a front elevational view of the audio speaker shown in FIG. 1;

FIG. 3 is a top plan view of the audio speaker shown in FIG. 1;

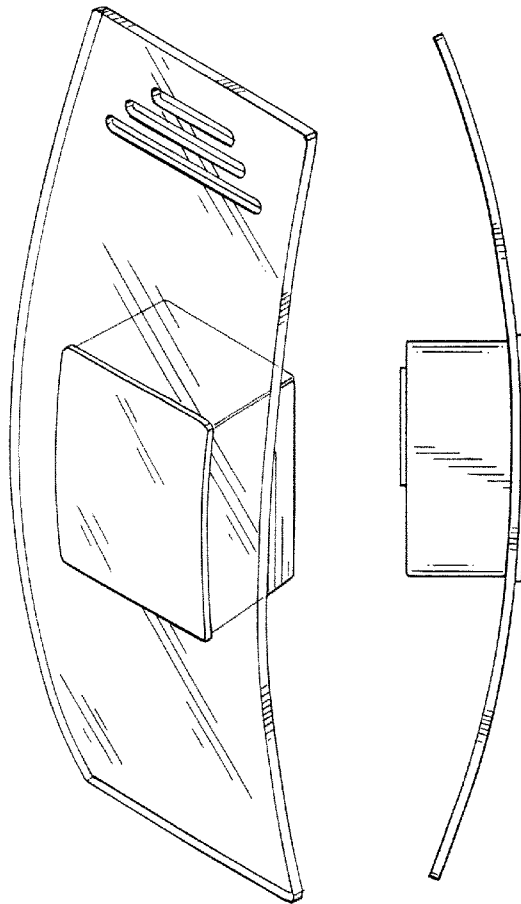
FIG. 4 is a bottom plan view of the audio speaker shown in FIG. 1;

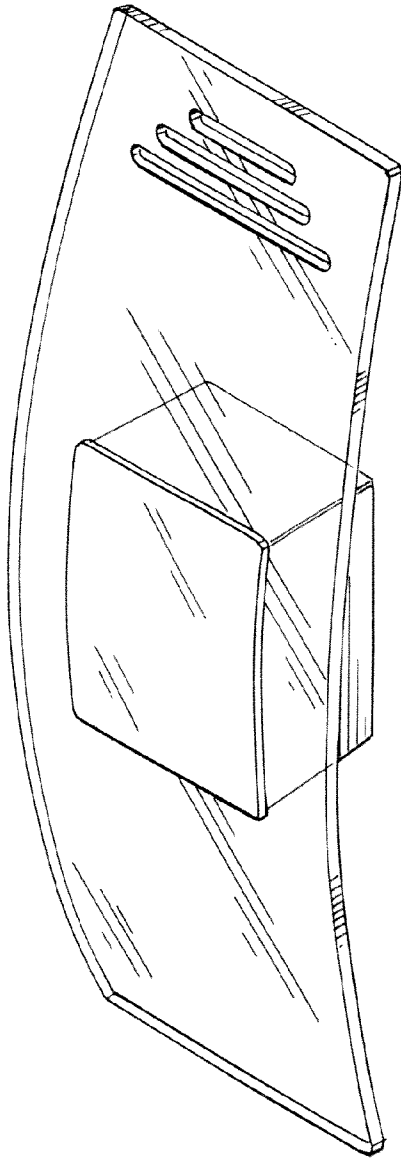

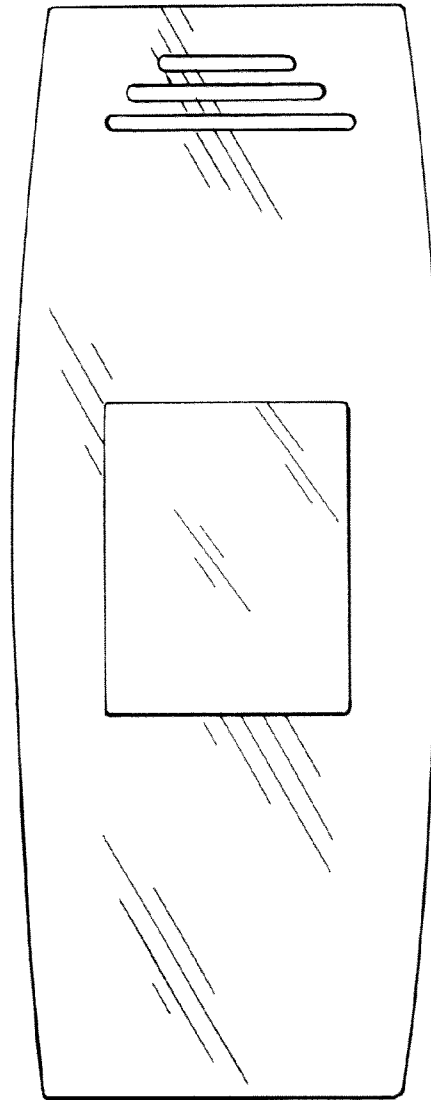

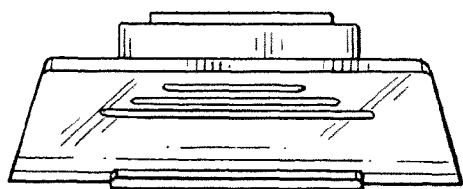

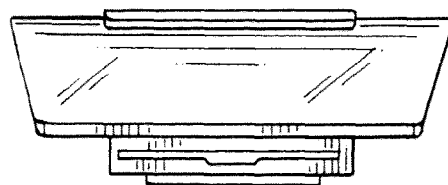

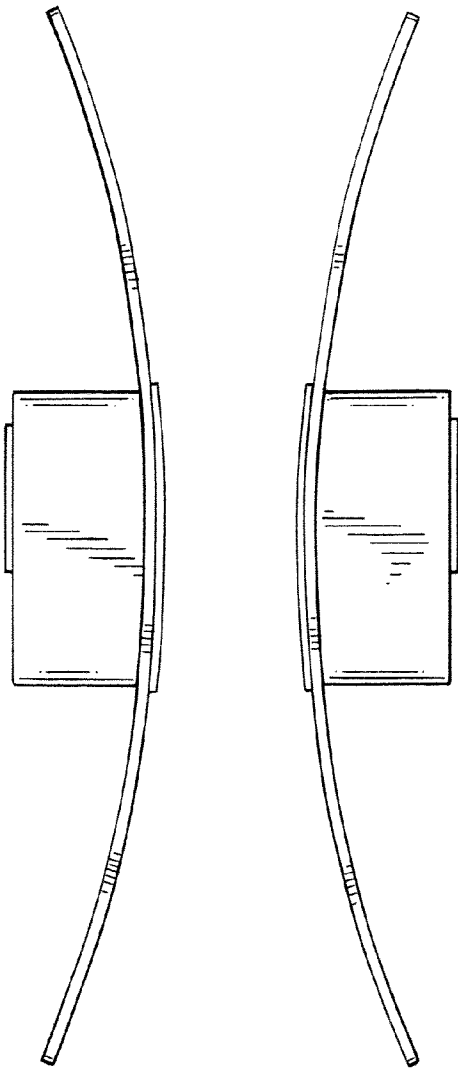

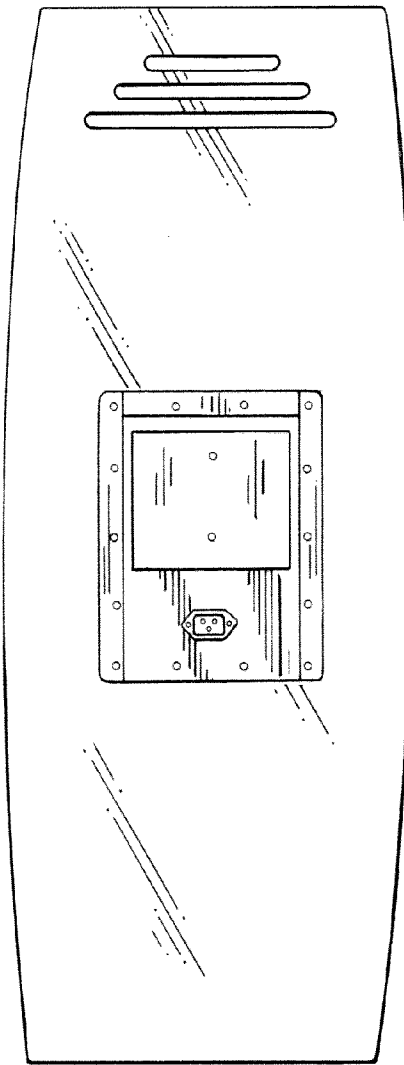
